NOTICE IS HEREBY GIVEN THAT THE **MIAMI TOWN COUNCIL** WILL HOLD A PUBLIC HEARING ON **MONDAY, JULY 25, 2016 AT 6:30 PM**, TO HEAR TAXPAYERS AT THE MIAMI TOWN COUNCIL CHAMBERS, 500 W. SULLIVAN STREET FOR THE FOLLOWING PURPOSE:

**TO APPROVE RESOLUTION NO. 1181 ADOPTING AND ACCEPTING THE TENTATIVE TOWN OF MIAMI BUDGET FOR FISCAL YEAR 2016/2017 (APPROVED BY THE MIAMI TOWN COUNCIL ON JUNE 27, 2016, PURSUANT TO RESOLUTION NO. 1178) AS THE FINAL BUDGET FOR THE TOWN OF MIAMI FOR FISCAL YEAR 2016/2017 AND APPROVING AN ALTERNATIVE EXPENDITURE LIMITATION IN AN AMOUNT EQUAL TO THE TOTAL AMOUNT OF BUDGETED EXPENDITURES/EXPENSES AS IT APPEARS ON THE ANNUAL BUDGET.**

FOLLOWING THE PUBLIC HEARING, THE COUNCIL MAY VOTE TO APPROVE THE TENTATIVE BUDGET AS THE FINAL BUDGET FOR FISCAL YEAR 2016/2017 AND APPROVE AN ALTERNATIVE EXPENDITURE LIMITATION FOR FISCAL YEAR 2016/2017.
