NOTICE IS HEREBY GIVEN THAT THE MIAMI TOWN COUNCIL WILL HOLD A PUBLIC HEARING ON **MONDAY, JULY 13, 2020 AT 6:30 PM**, TO HEAR TAXPAYERS AT THE MIAMI TOWN COUNCIL CHAMBERS, 500 W. SULLIVAN STREET FOR THE FOLLOWING PURPOSE:

TO APPROVE RESOLUTION NO. 1240 ADOPTING AND ACCEPTING THE TENTATIVE TOWN OF MIAMI BUDGET FOR FISCAL YEAR 2020/2021 (APPROVED BY THE MIAMI TOWN COUNCIL ON MAY 11, 2020 AS THE FINAL BUDGET FOR THE TOWN OF MIAMI FOR FISCAL YEAR 2020/2021 AND APPROVING AN ALTERNATIVE EXPENDITURE LIMITATION IN AN AMOUNT EQUAL TO THE TOTAL AMOUNT OF BUDGETED EXPENDITURES/EXPENSES AS IT APPEARS ON THE ANNUAL BUDGET.

FOLLOWING THE PUBLIC HEARING, THE COUNCIL MAY VOTE TO APPROVE THE TENTATIVE BUDGET AS THE FINAL BUDGET FOR FISCAL YEAR 2020/2021 AND APPROVE AN ALTERNATIVE EXPENDITURE LIMITATION FOR FISCAL YEAR 2020/2021.
