**NOTICE OF INTENT TO ESTABLISH FEES FOR PAVEMENT RESTORATION  
PURSUANT TO A.R.S. § 9-499.15**

The Town of Miami, intends to establish Pavement Restoration fees and provides this written notice of the proposed new fees pursuant to A.R.S. § 9-499.15.

The following fees are proposed:

Fee	Current Fee Amount	New Fee Amount
Pavement Restoration Fee (Year 1 after new pavement installation date)	Not Established	$\leq 45$ sq. ft. = \$40 per sq. ft. OR $> 45$ sq. ft. = \$1800 + \$10 per sq. ft.
Pavement Restoration Fee (Years 2-5 after new pavement installation date)	Not Established	$\leq 45$ sq. ft. = \$30 per sq. ft. OR $> 45$ sq. ft. = \$1350 + \$7 per sq. ft.
Pavement Restoration Fee (Years 6-10 after new pavement installation date)	Not Established	$\leq 45$ sq. ft. = \$16 per sq. ft. OR $> 45$ sq. ft. = \$720 + \$4 per sq. ft.

**The Miami Town Council will consider approving these proposed fees at its regular council meeting to be held April 23<sup>rd</sup>, 2018 in the Council Chambers, 500 West Sullivan Street, Miami, Arizona 85539. The Council meeting is scheduled to begin at 6:30 p.m.**

**THE ABOVE FEES WILL BECOME EFFECTIVE THIRTY (30) DAYS AFTER APPROVAL BY THE TOWN COUNCIL.**

A copy of the written report and data supporting the fees is available for review by the public in the office of the Town Clerk, 500 W. Sullivan Street, Miami, Arizona, during normal business hours, Monday through Friday, 8:00 a.m. to 5:00 p.m. and is posted concurrently with this Notice on the Town’s website at miamiaz.gov. Persons wishing to comment on the proposed changes may do so, in writing, prior to the public hearing to be held on the date listed above or may testify in person at the hearing.
