RESOLUTION NO. 1308

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF MIAMI, GILA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE GENERAL ELECTION HELD ON NOVEMBER 5, 2024.

WHEREAS, the Town of Miami, Gila County, Arizona did hold a general election on the 5th day of November, 2024 for the election of one (1) Councilmember and Proposition 418 related to approving an alternative expenditure limitation, Home Rule, for the Town, pursuant to Arizona Constitution, Article IX, Section 20, Subsection (9); and

WHEREAS, the election returns have been presented to and have been canvassed by the Town Council,

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Miami, Gila County, Arizona as follows:

Section 1: General Reporting

- A. That the total number of ballots cast at said general election for the Town, as reported by Gila County was 545.
- B. That the number of ballots rejected in the Town was 3.
- C. That the total number of active registered voters in the Town for the candidate election is 1,108.

Section 2: Candidate Election

- A. That the total number of votes cast at the said general election, as shown by the poll lists, was 419 for the one Council position to be filled and 489 for the ballot proposition.
- B. That the total number of votes by precincts received by each candidate is included as set forth in Exhibit A.
- C. Pursuant to Arizona Revised Statutes § 9-821.01(H), following the nomination of two candidates from the July 30, 2024 primary election, the candidate receiving the highest number of votes is declared elected to the one Council position.
- D. The votes cast for the candidates for Councilmember as set forth in Exhibit B (Summary) were as follows:

E. That it is hereby found, determined and declared of record, that the following candidate did receive the highest number of votes cast and is hereby issued a certificate of election:

Section 3: Proposition 418 – Home Rule Election

- A. That the total number of votes cast for and against ballot measure Proposition 418 – Home Rule was 489.
- B. That the total number of votes by precincts received for and against Proposition 418 is included as set forth in Exhibit A.
- C. That the votes cast for and against Proposition 418 – Home Rule as set forth in Exhibit B (Summary) were as follows:

Yes Votes: 254 No Votes: 235

D. It is hereby found, determined and declared of record, that Proposition 418, establishing an Alternative Expenditure Limitation, Home Rule, to govern the Town of Miami budget from fiscal year 2025/2026 to 2028/2029 did receive a majority of the total number of valid votes cast for this item and hereby shall be established.

Section 4: This resolution shall be in full force and effect immediately upon its adoption.


