property; establishing regulations for personal use at an individual's primary residence; imposing fees; providing for repeal of conflicting ordinances; providing for severability; and providing for penalties. The effect of the ordinance will be to adopt regulations in response to the "Smart and Safe Arizona Act" that has been certified as Proposition 207 and placed on the November 3, 2020 General Election Ballot.
