# REGULAR MEETING OF THE MAYOR AND COUNCIL MONDAY, AUGUST 22 2022 AT 6:30 PM

### 1. CALL TO ORDER:

Mayor Gonzales calls the meeting to order at 6:30 p.m.

# 2. PLEDGE OF ALLEGIANCE/INVOCATION:

Mayor Gonzales led the pledge of allegiance and Councilmember Medina gave the invocation.

A. Town Manager Reports.

Town Manager Rivera thanks staff for their support in his first 22 days as Town Manager. Comments on being prepared for the storm last week and support he had from staff and the Police Department. Thanks Council for the opportunity to be Town Manager for the Town of Miami.

# **B.** Mayor/Council Reports.

Councilmember Sosh comments on the electric sign boards on Highway 60; would like to see them used pointing trafficking into the downtown area and not just to advertise special events in town.

Councilmember Medina comments on stopping in at Town Hall and having a meeting with new Town Manager, Mr. Rivera. Councilmember Medina comments on a glitch with the CVIT welding program he teaches and he will not be teaching the fall semester, maybe things will be cleared up for the spring semester.

**B. Information, discussion and possible action:** To approve request by Miami Arts Commission to use Veterans Memorial Park, the snack bar and restrooms to host a Pumpkin Festival on Saturday, October 22<sup>nd</sup>, 2022 from 3:00 p.m. to 10:00 p.m.

Mrs. Joanna Twenty-three presents this request to Council. Mrs. Twenty-three explains they had their first Pumpkin Festival in 2018 and would like to have it again this year. They are working with several organizations to put this together. They don't have a lot of information yet as they are waiting for approval from Council to use the park before they move forward with the planning. They are trying to get volunteers to do a "haunted alley" in Sykes Alley, if so, they would like permission to use Sykes Alley from Inspiration to Keystone for the "haunted alley". Councilmember Black moved to approve request by Miami Arts Commission to use Veterans Memorial Park, the snack bar and restrooms to host a Pumpkin Festival on Saturday, October 22<sup>nd</sup> from 3:00 p.m. to 10:00 p.m. working with Town staff to close south of the road, parking area, and Sykes Alley. Motion seconded by Councilmember Reiman. Brief discussion regarding the event conflicting with another event scheduled in the park for that date. Mrs. Lisa Zaragoza states that she has already reserved and paid for the use of the park for that date. Mrs. Zaragoza's event ends at 2:00 p.m. and the Pumpkin Festival is requesting to start at 3:00 p.m. they should be able to work through the transition of one event to the other. Mrs. Twentythree states they can work with Mrs. Zaragoza so there will not be any issues with the events overlapping. Mayor Gonzales calls for the vote. Vote - Mayor Gonzales - aye, Vice Mayor
