# A. Town Manager Reports.

Town Manager Rivera recognizes and comments regarding the passing of former Supervisor Cruz Salas. Town Manager Rivera gives a brief update on the Veterans Park Project. The construction start date was delayed due to the weather, but should begin tomorrow. Update on the Freeport McMoRan funded projects; downtown beautification and textmygov software. The disc golf course project will start in March. Will be meeting with US Army Corps this week regarding the Mackey's Camp Project and Bloody Tanks Creek. Announce the U of A Project is off the table due to funding issues. States the hospital donated half a million dollars to the Town of Miami for the rehab of the Hostetler swimming pool. Hoping to start construction in February and be able to open up by June 1st. FEMA is waiting for confirmation from the Federal government on the letter approving the funds for Mackey's Camp. We are in the stage of presenting information and details, by AZ DEMA for the Mackey's Camp Bridge.

## B. Mayor/Council Reports.

Mayor Medina announce there will be an event this Saturday at the Bullion Plaza Museum, Mr. Tom Foster will give more information at the Call to the Public. Reminds Council that Financial Disclosure Statements are due before the end of this month.

## 7. CALL TO THE PUBLIC:

Mr. Tom Foster, Bullion Plaza Museum Executive Director, announces the completion of the mining diorama. It is up and running and it is interactive. This Saturday between 11:00 a.m. and 1:00 p.m. they are having, an invitation only for dignitaries, introduction. At approximately 1:00 p.m./1:15 p.m. they will have a ribbon cutting and then open to the public. Mr. Foster states it should be quite an event.

Gila County Supervisor Humprey comments on Tuesday's Board of Supervisor's meeting Board voted to table the Transit Funding Support IGA as no one from the Town of Miami showed up to present how the funds are being spent. Supervisor Humphrey states that it has been 2 years since the Board of Supervisors have had an update of the transit system. He is not against it but the board would like a report of what is going on with the funding. Supervisor Humphrey comments on his point of view of the Tri City Regional Sanitary District Sewer Project and why he is in support of it.
