REGULAR MEETING OF THE MAYOR AND COUNCIL MONDAY, SEPTEMBER 23, 2024 AT 6:30 PM

1. CALL TO ORDER:

Mayor Medina called the meeting to order at 6:30 p.m.

2. PLEDGE OF ALLEGIANCE/INVOCATION:

Reports on kickoff meeting with ATLAS Engineering for a housing grant to eradicate housing blight. Town Manager Rivera asks for continued prayers for Councilmember Gonzales and Councilmember Madrid's wife, Susan.
