# REGULAR MEETING OF THE MAYOR AND COUNCIL MONDAY, FEBRUARY 24, 2025 AT 6:30 PM

# 1. CALL TO ORDER:

Vice Mayor Gonzales called the meeting to order at 6:30 p.m.

#### 2. PLEDGE OF ALLEGIANCE/INVOCATION:

Pledge of Allegiance. Treyshawn Kumparak gave the invocation.

#### 6. REPORTS / RECOGNITIONS:

A. Town Manager Reports.

Town Manager Rivera reports on meeting with CAG to explore opportunities for a road project to enhance connectivity and safety within the community. The grant amount is \$2 million. The Town of Miami is applying for a \$300,000.00 grant from the Gila River Indian Community for essential resources and special police units. In partnership with ASU's Sustainable Cities Network and the Project Cities Program, the Town of Miami successfully finalized the Emergency Preparedness Plan. A brief update on the LED Lighting Project. Community Watch Program update. A brief update on the annexation process. Reports that the Town of Miami will convene with the Apache Gold Casino Enterprise to seek authorization for modifying the 2024 grant of \$12,274.98, reallocating it from police accessories to building enhancements; air conditioning.

# B. Mayor/Council Reports.

Councilmember Medina comments regarding using caliche to fill potholes and that he is continuing to research this.

Vice Mayor Gonzales gives thanks to the Town of Miami, the Town Manager, and the Chamber of Commerce for the Polar Plunge event. Vice Mayor Gonzales felt the event was well attended.

# 7. CALL TO THE PUBLIC:

Mrs. Evelyn Vargas, Economic Development Director, gives thanks to the sponsors who donated to the Polar Plunge event. Gives special thanks to the Globe-Miami Chamber of Commerce for doing all the "leg" work and supporting the event. Mrs. Vargas states that \$3,825.00 was raised for the Friends of the Miami Memorial Library, which allows them to buy books and supplies for the library.

Mr. Jesse Bryant, Globe resident, is speaking on behalf of the Gila County Public Safety Memorial Association. Mr. Bryant states that a monument is being built that will record all the names of public safety personnel who have died in the line of duty serving Gila County since 1881. Mr. Bryant wants to make Council aware of two names that will be on the memorial, Victor Hermes, Assistant Chief of the Miami Fire Department, date of passing was May 13, 1942 and George Edward Hicks, Special Officer with the Miami PD, date of passing was January 31, 1943. Mr. Bryant invites everyone to a ceremony on Thursday, May 15<sup>th</sup>, 11:00 a.m. at the Gila County Historical Museum, where the monument will be placed.

Mr. Treyshawn Kumparak, Miami High School sophomore class, gives a brief update on the "M" Hill Project and invites everyone to attend the picnic at the Veteran's park after working on the project.

Mr. Chuck Broeder, Miami resident/business owner, invites everyone to the Mardi Graus and Boomtown event, starting on Friday the 28<sup>th</sup>. Mr. Broeder gives a brief overview of the event schedule.

**B.** Information and discussion only: Discussion and clarification from the Town Attorney regarding the Town Council's power to approve the freeze on expenditures, including staff wage increase.

Town Attorney Estes explain the Town Manager has implemented certain spending freezes in light of statements coming out of Washington D.C. regarding federal funding and grants. The question had come up, if the Council as a whole, disagreed with the policy implementations, is there a process to address that with the Town Manager. The Town Manager is essentially the CEO and has the authority to run the town as he sees fit. With that said, the Council oversees the Town Manager. If there is a disagreement, it needs to be brought to a Council meeting for discussion and possible direction to the Town Manager if the majority of the Council is not in

agreement with how those matters are being handled. Town Attorney Estes suggests discussing these types of issues at the strategic planning meeting, so Council can establish goal and objectives for the manager to accomplish. Town Attorney Estes also comments on the question of retroactive pay when the salary freeze is over. Town Attorney Estes states that yes, they can be paid retroactive but it will be a Council decision. Vice Mayor Gonzales clarifies that the raises have to be allocated for in the budget, if not then it wouldn't apply. Town Attorney Estes states yes, that is correct. Open discussion and comments regarding how something like this would be an impact depending on the budget as well as what happens in emergency cases, such as what is happening with federal funding right now.

#### 10. CALL TO THE COUNCIL/FUTURE AGENDA ITEMS:

Councilmember Moat states his thoughts and prayers go out to Mrs. Christine Duarte's family as her daughter and her family were in a car accident this past weekend. There were some injuries, but everyone was okay.

Councilmember Medina comments on the passing of Annie Madrid, a long-time employee of the Catholic Church here in Miami. He extends his appreciation for the department reports and states he is very impressed with our Code Enforcement Officer, Ruben Mariscal. He thanks the public for attending the meeting.
